Notes for taking the Doctoral Degree Qualification Examination	1. According to the regulations of the paragraph (1) of the Article 6 in Doctoral Degree Regulations (a) : Graduate students only can apply for the Doctoral Degree Qualification Examination after acquiring at least 18 credits as required by the program. (Please submit the certificate of credits or transcripts over the years, which must include 4 or more credits in Physiology. Those who have acquired 4 or more credits in Physiology course have to provide the proof for exemption.) Since the Fall semester of 2017, the English proficiency of graduate students must meet the requirement level B2 , or graduate students must pass the English requirement after acquiring two or more English courses at the Language Center of Taipei Medical University. 2. The Doctoral Degree Qualification Examination is held once every year in September. 3. Written examination is taken first, and applicants cannot take the oral examination if they do not finish the written test.		
Description of the Doctoral Degree Qualification Examination	<p>1. Written examination: Examiners will provide six papers according to the applicant' s field of study.</p> <p>(1) The applicant will choose two of the six papers to answer.</p> <p>(2) For one of the selected papers, the applicant will analyze the insight of the paper, including literature review, study design, material and methods, results, and conclusion. The candidate should list at least ten of the doubts (including rationality and logics, but spelling, grammar, and school of thoughts are not counted).</p> <p>(3) For the other paper, the applicant will re-design the original study experiments and estimate the results (of the virtual experiments), then further explaining how the new design could acquire better results than the original paper.</p> <p>2. Oral examination: The applicant will give an oral report of the planned doctoral proposal, including the available research results and future plan.
